
The Derby Philosophers focuses upon the activities of a group of Midland intellectuals that included the evolutionist and physician Erasmus Darwin, Rev. Thomas Gisborne the evangelical philosopher and poet, Robert Bage the novelist, Charles Sylvester the chemist and engineer, William George and his son Herbert Spencer, the internationally renowned evolutionist philosopher who coined the phrase 'survival of the fittest', and members of the Wedgwood and Strutt families. The excitement of this intellectual world is evident from the fact that their circle included


Benjamin Franklin, Mathew Boulton, Richard Lovell and Maria Edgeworth, Jeremy and Samuel Bentham, Robert Owen, John Claudius Loudon and the poet Thomas Moore. The book explores how, inspired by science and through educational activities, publications and institutions including the famous Derbyshire General Infirmary (1810) and Derby Arboretum (1840), the Derby philosophers strove to promote social, political and urban improvements with national and international consequences. Far from being a parochial history of one intellectual group or town, this book examines science, politics and culture during one of the most turbulent periods of British history, an age of political and industrial revolutions in which the Derby philosophers were closely involved.

While they began as Latin exercises for his students, over the years Erasmus recognized the value of the form as a means of communicating his ideas on ecclesiastical reform.

First edition. William Falconer was an English physician and writer, as well as a Fellow of the Royal Society. This remarkable book is arranged in six parts: On the effect of climate; Of the influence of situation and extent of a country; On the influence of the nature of the country itself; On the influence of population; On the influence of the nature of food and diet; On the influence of way of life.

This is a view of the major influences of nature and population on ways of life. Chapter VII of book I offers views on the effects of temperatures and the climate on morals, sensibility, emotions of passion, pride, gallantry and intrigue, jealousy, cowardice, suspicion, fraud and knavery, perfidy and inconstancy, idleness, luxury, excess in diet, and gaming (a "destructive vice"). "Falconer's attainments as a scholar and a physician were of the highest order. He was intimate with Dr. Parr, who procured from the Cambridge University Press the publication of his 'Miscellaneous Tracts,' 1793, and who wrote of him in his 'Remarks on the Statement of Dr. Combe,' pp. 71-83 as 'a man whose knowledge is various and profound, and whose discriminations upon all topics of literature are ready, vigorous, and comprehensive.' In his will Parr referred to him in most flattering terms. Edmund Burke addressed a letter to Falconer, dated 14 Nov. 1790, thanking him 'for the temperate, judicious, and reasonable paper [on the French revolution] which appeared in the Bath prints some time since." – DNB VI.

In the 1930s it was not unusual for medical experts to caution against miscegenation, or race mixing, espousing the common opinion that it would produce biologically dysfunctional offspring. By the 1960s the scientific community roundly refuted this theory. 
"This well-documented study makes an innovative, interesting, and scholarly addition to the historiography of tuberculosis, especially in its comparative account of BCG. The author is undoubtedly wise to avoid an epidemiological assessment of results. No retrospective study can do this, much as we might wish it could. Poverty and its amelioration, however, are discussed but not well developed. While Canada's physician researchers took a biological, not a social approach to the disease, who dealt with the socioeconomic health of the country? Were they more successful than Americans in reducing poverty? If so, should their efforts get partial credit for reducing tuberculosis? Insofar as socioeconomic conditions do affect morbidity and mortality from tuberculosis, shouldn't they be included on both sides of the comparison? Or do these questions simply reflect the diathetic mind-set of an American physician?" – Barbara Bates, *ISIS: A Journal of the History of Science Society*, vol. 87.

Focusing specifically on the discourses that inform such genealogies, Generation and Degeneration moves from Greco-Roman times to the recent past to retrace generational fantasies and discords in a variety of related contexts, from the medical to the theological, and from the literary to the historical.

"The discourses on reproduction, biology, degeneration, legacy, and lineage that this book broaches not only bring to the forefront concepts of sexual identity and gender

politics but also show how they were culturally constructed and reconstructed through the centuries by medicine, philosophy, the visual arts, law, religion, and literature. The contributors reflect on a wide range of topics—from what makes men "manly" to the identity of Christ's father, from what kinds of erotic practices went on among women in sixteenth-century seraglios to how men's hemorrhoids can be variously labeled. Others investigate a psychomorphology of the clitoris that challenges Freud's account of lesbianism as an infantile stage of sexual development and such topics as the geographical origins of medicine and the materialization of genealogy in the presence of Renaissance theatrical ghosts.

"Following her husband, Albin C. Bro, Marguerite Harmon Bro served for many years as a Christian missionary in China. Her husband was also a Chicago based educator who served 1939-1949 as president of Francis Shimer women's junior college, and he was a reserve United States Foreign Service officer who served as a U.S. cultural attaché in China. The family was prominent in spiritualist circles. Albin Bro cofounded the Spiritual Frontiers Fellowship with fellow spiritualists Arthur Ford (Ford was a fraud artist who faked several famous séances) and Paul Higgins. Marguerite Bro herself helped bring national attention to the career of clairvoyant Edgar Cayce

through a September, 1943 article in Coronet Magazine. She also co-wrote Arthur Ford's "autobiography," Nothing So Strange, 1958.



"George Forster's A Voyage Round the World presents a wealth of geographic, scientific, and ethnographic knowledge uncovered by Cook's second journey of exploration in the Pacific (1772-1775). Accompanying his father, the ship's naturalist Johann Reinhold Forster, on the voyage, George proved a knowledgeable and adept

observer. The lively, elegant prose and critical detail of his account, based loosely on his father's journal, make it one of the finest works of eighteenth-century travel literature and an account of prime importance in the history of European contact with Pacific peoples. The Forsters' publications reveal the sophistication and enthusiasm they brought to their observation of Polynesian peoples as well as a sensitivity to the moral ambiguities of contact.

The two volumes of George Forster's work include substantially richer descriptions of encounters with island inhabitants than either his father's classic work (Observations Made during a Voyage round the World, UH Press, 1996) or Cook's official narrative, and its confident, even visionary, style incorporates a good deal of polemic, particularly in its criticism of the treatment of islanders by Cook's crew. In addition to the range and depth of its anthropological considerations, it provides a thrilling account of life aboard one of Cook's vessels.

In its author's German translation, this work becomes a classic of natural history writing, but its original English version has long been neglected by anglophone scholars. This new scholarly edition makes this important book readily available for the first time since its initial publication more than two centuries ago. But it also presents the work in fresh terms, making it more accessible and relevant to a contemporary audience. The valuable introduction and annotations draw on the wide range of anthropological and ethnohistorical scholarship published since the 1960s and contextualize the book in relation to both the cultures of Oceania documented by the Forsters and the history of European voyaging in the Pacific. One of the first proponents of germ theory, Fracastoro's beliefs on the subject were not wholly validated for another 300 years, when Pasteur and Koch proved the existence of microbes. Fracastoro was a classmate and friend of Copernicus. His famous poem, on Syphilis, was first issued in 1530. It is described by Garison and Morton as "The most famous of all medical poems." "The poem, drafted in Latin hexameter (about 1,300 verses) of exquisite beauty, occupies a prominent place in the literature of the times and represents a magnificent paradigm of formal sixteenth-century virtuosity in refined Latin of a didactic quality reminiscent of Vergil's Georgics" – *Dictionary of Scientific Biography*.

PROVENANCE: "Dr. Crawford W. Adams was a prominent cardiologist, bibliophile, and sportsman. He was a graduate of Boston University School of Medicine. He served in the US Air Force during World War II and moved to Nashville in 1947 where he became a prominent cardiologist. He served as a member of the clinical faculty at VUMC throughout his career. Crawford Adams was an avid collector of rare medical books. He was an authority on Vesalius and medical books that had fore-edge paintings. Dr. Adams donated his Vesalian collection to the Historical Collection in the Eskind Biomedical Library during the 1990s. Dr. Adams died in Nashville on December 13, 2003." – Vanderbilt University Medical Center. His library was sold at Sotheby's in New York, in 1982. The much celebrated collection featured a Vesalius and a stunning fore-edge painting collection of specimens from the Pilloni Library.




First edition in English. "This book represents a landmark in the development of our knowledge of infectious disease. Fracastoro was the first to state the germ theory of infection. He suggested the contagiousness of tuberculosis. Haeser even describes him as the "founder of scientific epidemiology". This book, which contains one of the first accounts of typhus (pp. 43-44), marks an epoch in the history of medicine, since Fracastorius enunciated in it, perhaps for the first time, the modern doctrine of the specific characters and infectious nature of fevers. He is remembered for his poem on syphilis, but he was also eminent as a physicist, geologist, astronomer, and pathologist.

An English translation by W. C. Wright appeared in 1930." [Garrison and Morton 2528 & 5371, this edition being the translation].

Wright, born in Britain, was associate professor of Greek in Bryn Mawr College. She translated many books for the Loeb Classical Library series.

Later edition of Schrockh's "eminent' biography of Luther," first published in 1773 (Backus & Benedict, p. 221). ¶ "Schrockh. . .sympathized with Erasmus' stand in the free-will controversy against Luther's extreme determinism, which, says Schrockh, the modern Protestant church does not feel committed to defend. . . .Schrockh stands by the narrower Lutheran definition of the Reformation. . . .In Planck and Schrockh, despite their differences, Protestantism and the Enlightenment remained in easy association" (Mansfield. p. 46).

"The notion of Luther as the embodiment of the German Volksgeist, for example, could not but degenerate into that of simple patriotism, or 'Luther the German.' On this view, when Luther enjoined obedience to the secular authorities on the occasion of the peasants' revolt, he laid the groundwork for 'respect for the authorities and for the inner peace of the state'—so says church historian, Johann Matthias Schrockh (1733-1808). Indeed, according to Schrockh, in the intervening centuries all of Europe should have come to understand that the Protestant religion 'is alone suited to the legitimate power and the true interests of the princes,' and that 'all of this is, without doubt, Luther's work'" (Perkins, pp. 69-70).

The frontispiece of Luther is fine example of German engraver Johann Benjamin Bruhl (1691-1763). ¶ Schrockh "was an Austrian-German historian and literary scholar born in Vienna. He was a grandson to Pietist preacher Matthias Bel (1684-1749)" (Wikip.).
